

PET PARK BOARDING KENNELS WAIVER

Please initial that you have read and understand each point.

1. I represent that I am the legal owner or agent for the owner of the dog described in the correlating application form.

2. I release Pet Park Boarding Kennels, its staff and owners, from any and all liability which my dog may suffer including but not limited to injury, sickness, damage or death resulting from participation in daycare or overnight boarding.

3. I represent that my dog is in good health, is current on all required vaccinations (DHPP DAPP Parvovirus, Rabies, Bordetella), is free of fleas, ticks, and lice, and as not been ill with any known contagious viruses in the last 30 days.

4. I understand that while my dog is fully vaccinated, vaccines are not guaranteed and there is a small risk that my dog may contract a contagious disease or illness. I agree that should this occur I am responsible for my own pet's care and medical attention.

5. I agree to allow a 7 days waiting period after my dog has had their vaccinations to allow the vaccines to reach full protection potential and to ensure my dog has not had any negative reaction to the vaccines. Should I allow my dog to stay at Pet Park Boarding Kennels less than 7 days after vaccination I understand that my dog could be at risk of contracting a contagious virus/disease.

6. I understand that dogs are not supervised in groups at all times, and that incidents of injuries may occur from playing with the other dogs, which include but not limited to bites, scrapes, scratches, and sprains. The staff at Pet Park does not leave dogs unattended if they feel it is unsafe for any animal.

7. I represent that my dog is sociable and has not harmed or shown threatening behaviours towards any person or any other dog. I understand Pet Park Boarding Kennels reserves the right to remove my dog from the play area and place my dog in a separate holding area should my dog display any unwanted behaviors. Alternatively I have informed Pet Park Boarding Kennels if my dog is not social and should remain separate. Any behavior problems that should be made known have been indicated on profile and/or discussed with staff.

8. I understand that Pet Park Boarding Kennels reserves the right to permanently remove a dog from its daycare or boarding facilities at any time.

9. I allow Pet Park Boarding Kennels staff to contact my veterinarian or any other accessible vet clinic as deemed necessary should any injuries require medical attention. I entrust the care and treatment of my pet to the discretion of the attending veterinarian and employee of the boarding facility, up to and including euthanasia if warranted. I agree that I am solely responsible for any medical expenses acquired for my dog.

10. I agree to disclose any previous or current medical issues or concerns of my dog so that Pet Park Boarding Kennels staff can make a determination of suitability for daycare or boarding.

11. I release Pet Park Boarding Kennels from any liability should my dog injure another dog or person and accept medical and legal responsibility for my dog's actions.

12. I release Pet Park Boarding Kennels from any liability should the death of my dog occur for any reason while in daycare or boarding.

13. I agree that my dog may be recorded on camera and its images may be used for Pet Park Boarding Kennels promotional material.

14. I understand that boarding services are charged on a pick up time of 2:00pm with drop off and pick up permitted only during hours of operation (8am-12pm or 2-6pm weekdays, 9-5 weekends). Boarding pick up during the afternoon hours of operation will be charged additionally at a corresponding daycare rate. I understand that Pet Park Boarding Kennel reserves the right to refuse after hours pick up.

15. I have had a staff member of Pet Park Boarding Kennels go over my profile form and consult me with any questions about information provided.

16. I agree to pay for any and all outstanding charges prior to or at time of pick up of my dog. I understand that should I not have provisions for payment at the time of pick up of my dog, Pet Park Boarding Kennels reserves the right to withhold my dog and continue to charge for continued services and any additional fees until payment is made in full.

17. In the event that you, your emergency contact, or any other person you have authorized to us in writing does not pick up your pet on the agreed upon departure date, you hereby authorize us to continue to provide boarding and any additional services at your expense. After 5 business days without contact the pet is deemed abandoned under provincial laws of Alberta, according to ASPCA and Pet Park Boarding Kennel will use its discretion permitted by law to follow the ABANDONED PET PROCEDURE .

ABANDONED DOG PROCEDURE:

We will attempt to contact you by telephone and/or in writing using the information that you have provided, advising you that if your dog is not picked up within 5 days, your dog will be deemed to be abandoned and we will deliver your dog to a third party adoption partner, animal shelter, or attempt to find a new owner for your dog. If you fail to pick-up your dog for any reason, you release Pet Park Boarding, its staff and owner from further liability and responsibility for your pet.

Cancellation Policies

Boarding Stays:

Regular Time: You will have up to 24 hours prior to your scheduled reservation to make any changes to your check in or check out dates. If less than 24 hours prior to check in you are:

-Making a change to the length of your stay (ex. Earlier pickup, later drop off) then you will have to pay for all the nights originally booked.

-Canceling the entire stay you will be required to pay for half of the stay.

Holidays (Including long weekends): You will have up to one week prior to your scheduled reservation to make any changes to your check in or check out dates. If less than a week prior to check in you are:

-Making a change to the length of your stay (ex. Earlier pickup, later drop off) then you will have to pay for all the nights originally booked.

-Canceling the entire stay you will be required to pay for half of the stay.

Daycare Stay: 24 hr notice is required to cancel a daycare stay. If notice is less than 24 hrs then you will be charged for that day, either on a card or you will have to pay before next day.
